

EU Declaration of Conformity for 02560

(1) The forestry safety helmet comprised the industrial helmet 02560, earmuff mounted helmet 02560 and mesh visor 02560.

The industrial helmet 02560 protects its wearer from head injuries caused by falling or flying objects and impact from stationary objects.

The ear protectors 02560 guard the wearer against noise. The ear protectors are only suitable for attachment to the ROCWOOD forestry safety helmet 02560.

This mesh visor 02560 is designed to protect the user against eye and face injuries through mechanical impact. The mesh visor is marked on the brow protection with a series of numbers and symbols to indicate the manufacturer, the field of use, the protector capabilities and performance characteristics of the face protector.
